

[Notes for readers: EcoLeaf common rules]

- A. "Production" stage is intended for two sub-stages listed below.

 (1) "Raw material" production: consists of mining, transportation and raw material production.

 (2) "Product" production: consists of the parts processing, assembly and installation.

 B. "Distribution" stage is intended for transportation of produced product. Transportation of consumables and maintenance goods (e.g. replacement parts) for use of the product are included into "Use" stage.

 A. Impact "by resource consumption" represents magnitude of impacts to resource depletion.
 B. Impact "by emission discharge to environment" represents magnitude of impacts to Atmosphere, Water and Soil system.
