# [Notes for readers: EcoLeaf common rules]

- L Stage related
  A. Production' stage is intended for two sub-stages listed below.

  (1) "Raw material" production: consists of mining, transportation and raw material production.

  (2) "Product" production: consists of the parts processing, assembly and installation.

  B. "Distribution" stage is intended for transportation of produced product. Transportation of consumables and maintenance goods (e.g. replacement parts) for use of the product are included into "Use" stage.
- C. "Use" stage is intended for use of the product (active mode, standby mode, etc.) and production, transportation to disposal/recycle of consumables/maintenance goods (e.g. replacement parts).

Case 2: Supply of used products to other businesses for material reclaim/parts reuse: Sum of increase of environmental impact by materials/parts reclaiming process, and decrease by volume reduction of new materials/parts production.

  A. Impact "by resource consumption" represents magnitude of impacts to resource depletion.

  B. Impact "by emission/discharge to environment" represents magnitude of impacts to Atmosphere, Water and Soil system.
