



- A. "Production" stage is intended for two sub-stages listed below
- (1) "Raw material" production: consists of mining, transportation and raw material production.

- A. Impact "by resource consumption" represents magnitude of impacts to resource depletion.
- B Impact "by emission/discharge to environment" represents magnitude of impacts to Atmosphere, Water and Soil system
